TEXAS CERTIFIED PUBLIC MANAGER (CPM) SCHOLARSHIP

NAMED IN HONOR
OF BARNEY L. KNIGHT

The Barney L. Knight Texas CPM Scholarship is an annual \$4,100 tuition scholarship awarded to one member of the Texas City Management Association. It provides a full tuition scholarship to the Texas CPM Program, which is sponsored by the William P. Hobby Center For Public Service at Texas State University-San Marcos.

The entire Texas CPM program consists of approximately 21 days of courses on finance, personnel, MIS, and other topics. Classes are offered periodically on the campus of Texas State University-San Marcos, and at many other locations throughout the state. The Texas CPM program requires a considerable commitment of time and study: **1-1½ days per month for a total of 14-21 months**. Successful graduates of the program earn the national designation of Certified Public Manager, and are eligible for college credit from Texas State University-San Marcos.

This scholarship covers the cost of tuition, fees, and materials. It does not include travel or lodging expenses. The tuition grant is active for a maximum of five years and only as long as the recipient is a public sector employee in Texas. CPM participants are encouraged to complete the courses as quickly as possible.
